Executive summary

This report provides statistical information on SQA Accreditation approved qualifications for the first quarter (Q1) of 2020–21 (1 April – 30 June 2020). This data is submitted by awarding bodies, who are responsible for quality assuring their data submissions.

Accredited qualifications

At the end of this period there were 789 accredited qualifications: 503 Scottish Vocational Qualifications (SVQs), 22 Regulatory and Licensing qualifications, and 264 'Other' qualifications.

Data submissions

There were a total of 6,650 (decrease of 79.3% from Q4) registrations and 9,229 (decrease of 62.5% from Q4) certifications in Q1.

SVQs

Of this total, 2,992 (45%) were SVQ registrations and 4,758 (51.6%) were SVQ certifications. The SQA awarding body had the highest percentage of SVQ registrations (93.4%) and certifications (88.9%). The developer with the most registrations and certifications was Skills for Care and Development — 50.1% and 37.3%, respectively.

Regulatory & Licensing qualifications

There were 495 registrations and 349 certifications, a decrease of 87.2% and decrease of 90.5% respectively compared to Q4. BIIAB accounted for 57% of registrations and Highfield Qualifications accounted for 55.3% of certifications. The developers with the most registrations were People 1st and other awarding bodies – 57.2% People 1st and the Scottish Government had the most certifications—54.4%.

'Other' qualifications

There were 3,163 registrations and 4,122 certifications, a decrease of 82.6% in registrations and 67.6% decrease in certifications. The Royal Academy of Dance (RAD) had the highest number of registrations — 20.8%. NEBOSH has the highest number of certifications — 48.4%. Qualification category

The area with the highest number of registrations and certifications is 003 Health Care, Social Care and Childcare, as it was in Q4.

Workplace Core Skills

There were a total of 2,995 registrations (a reduction of 70.4% compared to Q4) and 9,320 certifications (a decrease of 62.4% compared to Q4).

1 Introduction

SQA Accreditation is the national accrediting body for Scotland with a statutory remit under the Education (Scotland) Act 1996 to accredit and quality assure qualifications in Scotland. Although part of the Scottish Qualifications Authority, SQA Accreditation is distinct and autonomous from SQA's awarding function.

SQA Accreditation sets and specifies the requirements for accrediting qualifications to safeguard and support the interests of learners, parents, funding bodies, employers, providers and Scottish Government. We do this to promote and maintain public confidence in accredited qualifications and approved awarding bodies.

This report summarises the qualification data that has been provided to us by approved awarding bodies, referred to as data submissions. This information covers SQA accredited qualifications during the first quarter (Q1) of 2020–21 (1 April–30 June 2020) and shows the number of candidates who were:

- registered for an SQA accredited qualification
- certificated for an SQA accredited qualification

The data has been analysed in relation to:

- qualification type
- awarding body
- developer
- qualification category (classification)
- Workplace Core Skills

For upcoming data submissions, the following deadline dates apply and must be adhered to by all awarding bodies to ensure consistency and accuracy of data in future reports:



2 Accredited qualifications


At the end of Q1 of 2020-21 there were 789 live accredited qualifications.¹

- ◆ **503 SVQs** (63.8%)
- 22 Regulatory and Licensing qualifications (2.8%)
- ◆ 264 'Other' qualifications (33.5%)

¹ Note that this total does not include qualifications that are in their lapsing period.




Compared to Q4, the total number of accredited qualifications has decreased by one. The number of accredited qualifications has remained relatively stable in the last three years.



2.1 Total candidate registrations and certifications


2.1.1 Registrations

6,650 candidates were registered for SQA accredited qualifications in Q1.



This is a 79.3% decrease compared to Q4.

2.1.2 Certifications



9,229 certificates were awarded for SQA accredited qualifications in Q1.

This is a 62.5% decrease compared to Q4.

2.2 Top ten qualifications

The qualification with the highest number of registrations and certifications was the NEBOSH National General Certificate in Occupational Health and Safety.


The NEBOSH National General Certificate in Occupational Health and Safety had the highest number of certifications in Q1 of 2020–21. Compared to figures from Q4:

• Certifications for this qualification are 58% lower.

2.3 Registrations and certifications by qualification type

The following figures detail the number of registrations and certifications over a three-year period, broken down by qualification type. As there are peaks and troughs throughout the year for SVQs, it is more appropriate to compare the number of registrations and certifications to the equivalent quarter from the previous year rather than the preceding quarter.

2.3.1 SVQs



- Compared to Q1 of 2019–20, the number of SVQ registrations has decreased by 63%.
- SVQ certifications in Q1 2020–21 are 45% lower than those in Q1 of 2019–20.

2.3.2 Regulatory & Licensing (R&L)

- ♦ 495 registrations
- 349 certifications




Figure 3: SVQ Registrations & Certifications


In comparison to Q4 of 2019–20:

- R&L registrations are 87% lower in Q1 2020-21.
- R&L certifications are 90% lower in Q1 2020-21.

The peak in Q4 2018–19 can be attributed to the Scottish Certificate for Personal License Holders (Refresher) qualifications. The Licensing (Scotland) Act 2005 came into full effect in September 2009, and a refresher course is required every 5 years.

2.3.3 'Other' qualifications

- ♦ 3,163 registrations
- 4,122 certifications



In comparison to Q4 2019-20:

- registrations for other qualifications have decreased by 82.6%
- certifications for other qualifications have decreased by 67.6%

2.4 Analysis by awarding body

At the end of the first quarter there were 37 awarding bodies approved by SQA Accreditation. The number of qualifications offered by each awarding body varies greatly. The five largest awarding bodies, in terms of qualifications offered, are:



Registrations and certifications can be further categorised based on qualification type — SVQs, Regulatory & Licensing and 'Other'.

2.4.1 SVQs

SQA continues to have the highest number of SVQ registrations and certifications:

- 93.4% of registrations
- 88.9% of certifications




2.4.2 Regulatory and Licensing

BIIAB accounted for the highest number of R&L registrations:

• 57% of registrations

Highfield Qualifications accounted for the highest number of R&L certifications:

• 55.3% of certifications




2.4.3 'Other' qualifications

NEBOSH has the highest number of certifications:



2.5 Analysis by developer


This section compares the registrations and certifications by developer across the three qualification types — SVQs, Regulatory & Licensing, and 'Other'.

2.5.1 SVQs



SVQs are favoured across a wide range of developers. Skills for Care and Development account for the largest proportion of SVQ registrations and certifications — 50.1% and 37.3%, respectively.


2.5.2 Regulatory and Licensing



Compared to SVQs, Regulatory & Licensing qualifications are offered by a smaller range of developers and are largely in the Security and First Aid sectors. People 1st and other awarding bodies account for the largest proportion of registrations— 57.2% and People 1st and the Scottish Government have the highest number of certifications - 54.4%.

2.5.3 'Other' qualifications

While a wide range of organisations develop 'Other' qualifications across different industries, the majority of registrations can be attributed to a small number of developers, and hence a small number of sectors.



The largest proportion of registrations were in qualifications developed by the Royal Academy of Dance (RAD) — 20.8% of registrations. The largest proportion of certifications were in qualifications developed by NEBOSH — 48.4% of certifications.

The area with the highest number of registrations and certifications is 003 Health Care, Social Care and Childcare.

3 Workplace Core Skills

Workplace Core Skills are the broad, transferable skills that help to develop the main capabilities people need to be full, active and responsible members of society. Workplace Core Skills were specifically developed to assess Core Skills in a work environment. They contribute to employability and are a component of Modern Apprenticeships in Scotland. Each Workplace Core Skill is available at SCQF levels 3 to 6.

The five Workplace Core Skills are:

- Communication
- Information and Communication Technology (ICT)
- Numeracy
- Problem Solving
- Working with Others

At the end of Q1 2020-21, there were:

- 145 accredited Workplace Core Skills
- 2,995 registrations (a reduction of 70% compared to Q4)
- 3,502 certifications (an increase of 62.4% compared to Q4)

SQA continues to have the highest registrations and certifications for Workplace Core Skills:

- 86.3% of registrations
- 90.1% of certifications
